## **ACTION PLAN**

### **COOPERATION BETWEEN**

### **THE EUROPEAN COMMITTEE OF THE REGIONS**

### **AND CLIMATE ALLIANCE**

Following up on the Bureau decision of 12 October 2015 (CoR 2015/4495) establishing the procedure for the MoUs/Action Plans signed by the CoR with other entities/organisation and on the 2018 Action Plan, this document has the purpose to establish a multi-annual framework for the cooperation between:

- the European Committee of the Regions, the institutional body representing local and regional authorities in the EU (hereinafter referred to as the **CoR**); and
- the Climate Alliance of European Cities with Indigenous Rainforest Peoples, the European city network dedicated to climate action (hereinafter referred to as **Climate Alliance**).

Both signatories of the present Action Plan:

#### **ACKNOWLEDGE THAT:**

- Local and regional governments are key drivers of the **energy transition** and the **fight against climate change** at the level of governance closest to citizens;
- Local and regional authorities are major actors in **shaping climate and energy policies** – in compliance with the principle of subsidiarity – at the European level as well as in the international arena;
- A well-functioning **multi-level governance** framework is of crucial importance to support a vertical integration and foster cooperation between the different levels of government – especially in the preparation and implementation of the national, regional and local sustainable energy and climate strategies and plans;
- Securing **financing opportunities** for local and regional governments remains one of the main challenges to support climate and energy projects on the ground.

## HIGHLIGHT:

- Their **shared political interest** in strengthening the voice of European local and regional governments on climate and energy issues in the EU and on the international scene;
- Their **rich history of fruitful cooperation** on these issues at the EU level (e.g. the recent CoR's opinion in the review of the EU Adaptation Strategy for which Climate Alliance was designated as expert) as well as in the international climate negotiations (e.g. several co-organised side-events at the Conferences of the Parties to UNFCCC).

## COMMIT TO FURTHER INTENSIFYING THEIR COOPERATION IN THE FOLLOWING AREAS:

### 1) EU Climate and Energy Policy Framework

- Participation in relevant consultation processes (e.g. CoR's stakeholder events, Climate Alliance's working group meetings as well as other debates and conferences organised by partners);
- Contribution of the CoR to Climate Alliance's position papers and policy recommendations;
- Engagement of Climate Alliance (staff and/or member local authorities) in the preparation and dissemination of CoR opinions and studies;
- Preparation of joint publications.

### 2) International Climate Negotiations

- Co-organisation of side-events at UNFCCC Conferences of the Parties (COPs);
- Exchange on positions ahead of UNFCCC COPs and other relevant international events ;
- Joint discussions with relevant international (institutional/financing) stakeholders.

### 3) Exchange opportunities between local and regional governments and European decision-makers (e.g. events or others)

- Participation in their respective events (e.g. speaking opportunities at workshops, roundtables, conferences) or other types of activities;
- Promotion of their respective activities among their members and partners.

Both signatories agree on the content of the multi-annual framework for cooperation (Annex I)<sup>1</sup> and on the 2019-2020 roadmap to bring forward shared priorities and identify joint activities (Annex II).

Both signatories also agree on the fact that the present Action Plan does not involve a commitment to disburse funds. It is rather based on the assumption that each signatory will implement the activities envisaged in this document covering its own costs and using its own resources in accordance to the signatories' respective regulations, rules and standard practices.

## **Annex II: Roadmap 2019-2020**

---

Possible joint activities will include:

- Policy Work: development of common positions on Energy Poverty and other relevant themes (see above list, page 8), the ‘Low Carbon Mobility’ Package, the Strategy for long-term EU greenhouse gas emissions reductions (e.g. through CoR opinions, policy recommendations or similar)
- Joint work on multi-level governance in National Energy and Climate Plans. This could include work on local and regional inputs into the plans and reviews of draft plans from a local and regional perspective
- Covenant of Mayors: cooperation with the CoR Ambassadors and CoR regions engaged as Covenant Coordinators, co-organisation of (EU and national) Covenant of Mayors Events, participation in thematic Coalitions on financing, adaptation and energy poverty
- EU Urban Agenda Partnerships: participation in relevant policy discussions (adaptation, but also energy transition).
- International climate negotiations: co-organisation of side-events at COPs, participation in relevant events for Committee of the Regions representatives.
- Cities and Regions for Development Cooperation 2019: co-organisation of thematic discussions and workshops.
- Energy transition in islands: commitments to support climate alliance in their work with the clean energy transition on islands in the framework of clean energy for EU island secretariat. Namely the participation to the development of the initiative through the Co-development platform and attendance at events and workshops. Climate Alliance to provide inputs to the ENVE committee and their focus on decarbonisation of EU islands.
- Locally and Regionally Determined Contributions: Joint work to define Locally and Regionally Determined Contributions (as proposed in Mr Cooper’s Opinion on post 2020 Climate Governance). This could include analysis of country case studies where the contribution of subnational entities and local authorities to NDCs is already recognised or taken in account by the national institutions.
