ABOUT THE COVENANT OF MAYORS EUROPE

The Covenant of Mayors for Climate and Energy - Europe brings together local authorities voluntarily committed to meeting or even exceeding the EU climate and energy objectives. Since its launch in 2008, the initiative has mobilised over 10,500 local authorities in Europe, covering roughly one third of the EU population. Signatory cities pledge action to support the EU in reaching carbon neutrality by 2050. They commit to delivering actions to reduce greenhouse gas emissions in the given territory, increase resilience and prepare for the adverse impacts of climate change, and tackle energy poverty to ensure a just transition towards climate neutrality.

The Policy Support Facility (PSF) on adaptation to climate change was launched to assist local and regional authorities develop and implement adaptation strategies under the Covenant of Mayors Europe. Activities

under the PSF will run throughout 2022 and 2023 and include public seminars, national workshops, tailored technical assistance and peer learning exchanges with local authorities across 12 European countries.

Climate Alliance leads the Covenant of Mayors – Europe office and co-coordinates the PSF.

- Draft progress reports – with the support of the team involved
- Regularly liaise and report to the European Commission DG Climate Action
- Maintain and further develop strategic partnerships with key institutions and engage with potential facility partners
- Promote results and activities internally and externally
- Ensure synergies with other relevant Climate Alliance projects and activities
- Lead the Covenant of Mayors Coalition of the Willing on Adaptation

- Experience in project proposal preparation and writing for tenders/service contracts with the European Commission
- A Master's Degree in a relevant field (e.g. international relations, European affairs, environment, energy, climate change)
- Excellent relationship management, coordination, and communication skills, fluency in English (written and public-speaking)
- Good networking abilities and interpersonal skills for an international environment
- Ability to demonstrate initiative and proactivity with daily tasks
