Response to consultation

Towards a new European Neighbourhood Policy

Brussels 30 June 2015

Empowering local authorities and building a decentralized sustainable energy system should become central pillars of the revised European Neighbourhood Policy (ENP). Experience, notably with the Covenant of Mayors East and the CES-MED, has shown that this approach is suited to tackle central challenges of the ENP identified in the consultation document.

The Covenant of Mayors (CoM) East initiative was launched in 2011 to support these goals, and is currently financed by DG NEAR. Building on the tremendous success of the Covenant of Mayors in the EU, it now gathers 152 local authorities in 11 countries in the Eastern Neighbourhood countries and central Asia. The CoM East has already greatly enhanced the capacities of local administrations to tackle energy challenges. By increasing decentralised energy production from renewable sources and decreasing energy consumption, it has greatly contributed to enhancing energy security, which is a clear common interest of the EU and its partner countries.

This approach helps reducing dependences on one or a few energy suppliers and also yields multiple benefits in terms of climate action, creation of local jobs and empowering local communities.

Working with the local authorities in the neighborhood countries is a prerequisite for achieving concrete results and actual change, as the 64 Sustainable Energy Action Plans developed so far under the CoM East framework confirm. The unique governance model of the Covenant has also enabled the empowerment of local authorities in the neighbourhood and needs to continue to do so, as a bottom-up initiative based on the voluntary commitment of local authorities. Involving a large range of stakeholders and civil society, it has increased ownership of the ENP. It incentivizes public authorities in partner countries to practice a new way of collaborating and to get involved in the ENP: national ministries, regions or energy agencies act as Covenant Coordinators and support local authorities to develop and implement their action plans.

Based on these experiences, Climate Alliance puts forward the following recommendations for the new European Neighbourhood Policy:

The ENP should

- put a further focus on cities / local authorities and their role in increasing energy security and other policy priorities identified by the background paper;
- enhance its focus on local climate and energy action and strengthen the Covenant of Mayors as a tool in this context;
